S. R. O. No. 149/2015. In exercise of the powers conferred by section 254 read with section 235AB of the Kerala Panchayat Raj Act, 1994 (13 of 1994), the Government of Kerala hereby make the following Rules, further to amend the Kerala Panchayat Building (Regularisation of Unauthorised Construction) Rules, 2014, issued as G. O. (Ms.) No. 150/2014/LSGD. dated 21st August, 2014, and published as S. R. O. No. 519/2014 in the Kerala Gazette Extraordinary No. 2145, dated 27th August, 2014, namely:---

RULES

1. *Short title and commencement.*---(1) These Rules may be called the Kerala Panchayat Building (Regularisation of Unauthorised Constructions) Amendment Rules, 2015.

(2) They shall be deemed to have come into force on the 27th day of August, 2014.

2. *Amendment to the Rules.*—In the Kerala Panchayat Building (Regularisation of Unauthorised Construction) Rules, 2014, in Rule 3, in sub rule (1), for the figures '90' the figures '308' shall be substituted.

Explanatory Note

(This does not form part of the notification, but is intended to indicate its general purport.)

As per sub rule (1) Rule 3 of the Kerala Panchayat Building (Regularisation of Unauthorised Construction) Rules, 2014, issued as G. O. (Ms.) No. 150/2014/LSGD. and published as S.R.O. No. 519/2014 in the Kerala Gazette Extraordinary No. 2145 dated 27th August, 2014, the time-limit for filing the application for regularization of unauthorised construction was 90 days. The said time-limit expired on 24-11-2014. Therefore, Government have decided to extend the time limit for a further period of 218 days from 25-11-2014 so as to provide opportunity to those who could not file application for regularization of unauthorised construction in time.

This notification is intended to achieve the above object.
