S. R. O. No. 499/2017.—In exercise of the powers conferred by sub-section (3) of section 218 of the Kerala Panchayat Raj Act, 1994 (13 of 1994), the Government of Kerala, after consulting the Cherpu Grama Panchayat hereby exclude from the operation of the said Act, the land specified in the schedule below which is vested in the said Panchayat and registered in the revenue records as 'puramboke kulam', namely:—

Explanatory Note

(This does not form part of the notification, but is intended to indicate its general purport.)

The land in Re-survey Number 314/5 of Chevoor Village of Thrissur Taluk, Thrissur District measuring an extent of 0.0350 H (8.645 Cent) stands registered as 'puramboke kulam' in the revenue records and it is vested with Cherpu Grama Panchayat under Section 218 of the Kerala Panchayat Raj Act, 1994 (13 of 1994).

The Government, after consulting the Cherpu Grama Panchayat, have decided to exclude the said land specified in the schedule above from the provisions of the Kerala Panchayat Raj Act, 1994, so as to enable the Revenue Department to transfer the land to the Deputy Excise Commissioner, Thrissur for the construction purpose of Excise Range Office, Cherpu.

The notification is intended to achieve the above object.
