WHEREAS, nine members of the Kallara Grama Panchayat had given notice of no-confidence motion against Shri K. Shantha Kumar, President, Kallara Grama Panchayat on 12th July, 2019;

AND WHEREAS, a meeting of the said Grama Panchayat was held on 27th July, 2019 in the said Grama Panchayat Office under the Presidentship of the Secretary, Vamanapuram Block Panchayat to consider the said no-confidence motion;

AND WHEREAS, in the said meeting, out of the sanctioned strength of seventeen members, nine members have voted in favour of the no-confidence motion and the Secretary,



Vamanapuram Block Panchayat has declared the no-confidence motion against Shri. K. Shantha Kumar as passed;

AND WHEREAS, after the passing of the said no-confidence motion, the term of office of the President of the said Grama Panchayat has come to an end and the Secretary, Vamanapuram Block Panchayat has reported the occurrence of the vacancy in the office of the President of the said Grama Panchayat to the Government and the State Election Commission;

AND WHEREAS, the said matter has been published in the notice board of the said Grama Panchayat;

Now, Therefore, in exercise of the powers conferred by sub-section (12) of section 157 of the Kerala Panchayat Raj Act, 1994 (13 of 1994), the Government of Kerala hereby notify that Shri K. Shantha Kumar has ceased to hold his office as President of the Kallara Grama Panchayat with effect from 27th July, 2019.

## **Explanatory Note**

(This does not form part of the notification, but is intended to indicate its general purport.)

Government have decided to notify that Shri K. Shantha Kumar has ceased to hold his office as the President of Kallara Grama Panchayat with effect from 27th July, 2019 consequent on passing of no-confidence motion against him by the Panchayat.

The notification is intended to achieve the above object.
