WHEREAS, eleven members of the Chorodu Grama Panchayat had given notice of no-confidence motion against Smt. K. K. Nalini, President, Chorodu Grama Panchayat on 4th February, 2019;

AND WHEREAS, a meeting of the said Grama Panchayat was held on 16th February, 2019 in the said Grama Panchayat Office under the Presidentship of the Secretary, Vadakara Block Panchayat to consider the said no-confidence motion;



AND WHEREAS, in the said meeting, out of the sanctioned strength of twenty one members, eleven members have voted in favour of the no-confidence motion and the Secretary, Vadakara Block Panchayat has declared the no-confidence motion against Smt. K. K. Nalini as passed;

AND WHEREAS, after the passing of the said no-confidence motion, the term of office of the President of the said Grama Panchayat has come to an end and the Secretary, Vadakara Block Panchayat has reported the occurrence of the vacancy in the office of the President of the said Grama Panchayat to the Government and the State Election Commission;

AND WHEREAS, the said matter has been published in the notice board of the said Grama Panchayat;

NOW, THEREFORE, in exercise of the powers conferred by sub-section (12) of section 157 of the Kerala Panchayat Raj Act, 1994 (13 of 1994), the Government of Kerala hereby notify that Smt. K. K. Nalini has ceased to hold her office as President of the Chorodu Grama Panchayat with effect from 16th February, 2019.

Explanatory Note

Government have decided to notify that Smt. K. K. Nalini has ceased to hold her office as the President of Chorodu Grama Panchayat with effect from 16th February, 2019 consequent on passing of no-confidence motion against her by the Panchayat.
