WHEREAS, eight members of the Peerumedu Grama Panchayat had given notice of no-confidence motion against Smt. Rajani Vinod, President, Peerumedu Grama Panchayat on 1st August, 2019;

AND WHEREAS, a meeting of the said Grama Panchayat was held on 16th August, 2019 in the said Grama Panchayat Office under the Presidentship of the Secretary, Azhutha Block Panchayat to consider the said no-confidence motion;



AND WHEREAS, in the said meeting, out of the sanctioned strength of fifteen members, eight members have voted in favour of the no-confidence motion and the Secretary, Azhutha Block Panchayat has declared the no-confidence motion against Smt. Rajani Vinod as passed;

AND WHEREAS, after the passing of the said no-confidence motion, the term of office of the President of the said Grama Panchayat has come to an end and the Secretary, Azhutha Block Panchayat has reported the occurrence of the vacancy in the office of the President of the said Grama Panchayat to the Government and the State Election Commission;

AND WHEREAS, the said matter has been published in the notice board of the said Grama Panchayat;

NOW, THEREFORE, in exercise of the powers conferred by sub-section (12) of section 157 of the Kerala Panchayat Raj Act, 1994 (13 of 1994), the Government of Kerala hereby notify that Smt. Rajani Vinod has ceased to hold her office as President of the Peerumedu Grama Panchayat with effect from 16th August, 2019.

Explanatory Note

Government have decided to notify that Smt. Rajani Vinod has ceased to hold her office as the President of Peerumedu Grama Panchayat with effect from 16th August, 2019 consequent on passing of no-confidence motion against her by the Panchayat.

The notification is intended to achieve the above object.
