AND WHEREAS, in the said meeting, out of the sanctioned strength of seventeen members, nine members have voted in favour of the no-confidence motion and the Secretary,

Vamanapuram Block Panchayat has declared the no-confidence motion against

Smt. G. S. Beena as passed;

AND WHEREAS, after the passing of the said no-confidence motion, the term of office of

the Vice-President of the said Grama Panchayat has come to an end and the Secretary,

Vamanapuram Block Panchayat has reported the occurrence of the vacancy in the office of the

Vice-President of the said Grama Panchayat to the Government and the State Election

Commission;

AND WHEREAS, the said matter has been published in the notice board of the said Grama

Panchayat;

Now, Therefore, in exercise of the powers conferred by sub-section (12) of section 157

of the Kerala Panchayat Raj Act, 1994 (13 of 1994), the Government of Kerala hereby notify

that Smt. G. S. Beena has ceased to hold her office as Vice-President of the Kallara Grama

Panchayat with effect from 27th July, 2019.
