WHEREAS, five members of the Vellavoor Grama Panchayat had given notice of no-confidence motion against Sri T. S. Sreejith, Vice-President, Vellavoor Grama Panchayat on 27th November, 2019;

AND WHEREAS, a meeting of the said Grama Panchayat was held on 10th December, 2019 in the said Grama Panchayat Office under the Presidentship of the Secretary, Vazhoor Block Panchayat to consider the said no-confidence motion;

AND WHEREAS, in the said meeting, out of the sanctioned strength of thirteen members, seven members have voted in favour of the no-confidence motion and the Secretary, Vazhoor Block Panchayat has declared the no-confidence motion against Sri T. S. Sreejith as passed;

AND WHEREAS, after the passing of the said no-confidence motion, the term of office of the Vice-President of the said Grama Panchayat has come to an end and the Secretary, Vazhoor Block Panchayat has reported the occurrence of the vacancy in the office of the Vice-President of the said Grama Panchayat to the Government and the State Election Commission;

AND WHEREAS, the said matter has been published in the notice board of the said Grama Panchayat;

Now, Therefore, in exercise of the powers conferred by sub-section (12) of section 157 of the Kerala Panchayat Raj Act, 1994 (13 of 1994), the Government of Kerala hereby notify that Sri T. S. Sreeejith has ceased to hold his office as Vice-President of the Vellavoor Grama Panchayat with effect from 10th December, 2019.

#### **Explanatory Note**
