WHEREAS, seven members of the Puramattam Grama Panchayat had given notice of no-confidence motion against Shri Vineeth Kumar, Vice-President, Puramattam Grama Panchayat on 29th June, 2020;

AND WHEREAS, a meeting of the said Grama Panchavat was held on 15th July, 2020 in the said Grama Panchayat Office under the Presidentship of the Secretary, Koipuram Block Panchayat to consider the said no-confidence motion;



AND WHEREAS, in the said meeting, out of the sanctioned strength of thirteen members, eight members have voted in favour of the no-confidence motion and the Secretary, Koipuram Block Panchayat has declared the no-confidence motion against Shri Vineeth Kumar as passed;

AND WHEREAS, after the passing of the said no-confidence motion, the term of office of the Vice-President of the said Grama Panchayat has come to an end and the Secretary, Koipurarn Block Panchayat has reported the occurrence of the vacancy in the office of the President of the said Grama Panchayat to the Government and the State Election Commission;

AND WHEREAS, the said matter has been published in the notice board of the said Grama Panchayat;

Now, THEREFORE, in exercise of the powers conferred by sub-section (12) of section 157 of the Kerala Panchayat Raj Act, 1994 (13 of 1994), the Government of Kerala hereby notify that Shri Vineeth Kumar has ceased to hold his office as Vice-President of the Puramattam Grama Panchayat with effect from 15th July, 2020.
