WHEREAS, nine members of the Azhiyoor Grama Panchayat had given notice of no-confidence motion against Sri E. T. Ayoob, President, Azhiyoor Grama Panchayat on 25th September, 2019;

AND WHEREAS, a meeting of the said Grama Panchayat was held on 11th October, 2019 in the said Grama Panchayat Office under the Presidentship of the Secretary, Vadakara Block Panchayat to consider the said no-confidence motion;



AND WHEREAS, in the said meeting, out of the sanctioned strength of eighteen members, ten members have voted in favour of the no-confidence motion and the Secretary, Vadakara Block Panchayat has declared the no-confidence motion against Sri E. T. Ayoob as passed:

AND WHEREAS, after the passing of the said no-confidence motion, the term of office of the President of the said Grama Panchayat has come to an end and the Secretary, Vadakara Block Panchayat has reported the occurrence of the vacancy in the office of the President of the said Grama Panchayat to the Government and the State Election Commission;

AND WHEREAS, the said matter has been published in the notice board of the said Grama Panchayat;

Now, THEREFORE, in exercise of the powers conferred by sub-section (12) of section 157 of the Kerala Panchayat Raj Act, 1994 (13 of 1994), the Government of Kerala hereby notify that Sri E. T. Ayoob has ceased to hold his office as President of the Azhiyoor Grama Panchayat with effect from 11th October, 2019.

### **Explanatory Note**
