As per the letter read as 2nd paper above, Government of India have sanctioned the grant-in aid amount of Rs.1,19,17,500/-(General), Rs.69,12,150/-(SCP), Rs.50,05,350/- (TSP) respectively to the State towards the part payment of first installment of central share in respect of Annual Action Plan (AAP) under Mahila Kissan Sashaktikaran Pariyojana (MKSP) Value Chain Project by Kudumbashree Mission, Kerala SRLM.
