ORDER

As per the letter read as 2nd paper above, Government of India have sanctioned the grant-in aid amount of Rs.2,45,40,000/-(General), Rs.1,42,33,000/-(SCP), Rs.1,03,07,000/- (TSP) respectively to the State towards the part payment of second installment of central share in respect of Mahila Kissan Sashaktikaran Pariyojana (MKSP) Attappady Project under Annual Action Plan (AAP) for attaining economic empowerment, food, nutritional and livelihood security from Kudumbashree Missionm, Kerala SRLM. This amount already credited to the bank account of Kudumbashree through RTGS. As per the letter read as 3rd above, Executive Director, Kudumbashree has submitted proposal for releasing the corresponding State share amount of Rs.3,27,20,000/-(Rupees Three Crore Twenty Seven Lakhs and Twenty Seven Thousand Only) for the above purpose.
