ORDER

Sri. Ananda Raju. B. Lee Engineer (Rtd) has liked ONEKND 977 2019 before the Hon'ble Kerala Administrative Tribunal aggrieved by the non-declaration of his probation in the cadre of Executive Engineer.

- 2. The Hon'ble Kerala Administrative Tribunal, vide orders read as 2nd paper above, has disposed of the OA directing the first respondent, ie the Govt to consider the declaration of probation of the applicant as well in the light of the Annexure A5 report, read as 1st paper above and to pass appropriate orders within a period of two months from the date of receipt of a copy of the order and to issue consequential orders by the 2nd respondent, ie Chief Engineer, LSGD thereafter.
- 3. The applicant was promoted to the cadre of Executive Engineer/Town Planning officer in Municipal Common Service as per GO(Rt)No.439 2007/LSGD dated 14 02:2007 and joined-duty in Thiruvananthapuram Corporation on 15:02:2007. The Chief Engineer has certified that the work and conduct of the incumbent, who retired from service on superannuation on 31:05:2017, was good during his probation period from 15:02:2007 to 14:02:2008. The Chief Engineer has also reported that the incumbent has not availed any kind of leave other than casual leave, during his probation period and that no Vigilance cases/disciplinary actions are pending against him. The disciplinary actions prevailed against him have been finalized vide GO(Rt)No.207/2019/LSGD dated 31:01:2019 and GO(Rt)No.548/2019/LSGD dated 07:03:2019.
- 4. In the above circumstances, the probation of Sri. Ananda Raju. B, Exc.Engineer (Rtd) in the Executive Engineer cadre is declared to have been satisfactorily completed w.e.f 15.02.2008 FN, as per Rule 20(b) Part II KS&SSRs.
