As per letter read as 1st paper above Government of India have released ₹41,02,35,000/-((Rupees Forty one Crore and Two Lakh Thirty five thousand only)) as the 1st installment of program fund to Government of Kerala under Pradhan Manthri Gram Sadak Yojana (PMGSY) for the year 2019-20. As the funding pattern between Central & State Government under PMGSY is 60:40 the State Govt. has to release an amount of 27,34,90,000/- (Rupees Twenty seven Crore Thirty four Lakh Ninety thousand only) as corresponding State Share along with the Central Share received. As per the letter read as 2nd paper above, the Member Secretary, KSRRDA has submitted necessary proposal for the release of the aforesaid central share and the corresponding state share under the H/A 2515-800-74-01 and 2515-800-74-02 respectively.

2) Government have examined the matter in detail and are pleased to accord to release an amount of ₹41,02,35,000/-((Rupees Forty one Crore and Two Lakh Thirty five thousand only)) to KSRRDA, as 1st instalment of Central Share of Programme Fund under Pradhan Mantri Gram Sadak Yojana (PMGSY) for the year 2019-20 along with the matching State Share of ₹27,34,90,000/- (Rupees Twenty seven Crore Thirty four Lakh Ninety thousand only) by debiting the expenditure under the H/A 2515-800-74-01 and 2515-800-74-02 respectively and to transfer credit the amount to the PSTSB Account No.799012700000447 of Commissioner for Rural Development and Member Secretary, KSRRDA at District Treasury, Thiruvananthapuram.
