**ORDER**

As per the letter read as 2<sup>nd</sup>, 3<sup>rd</sup> and 4<sup>th</sup> papers above, Government of India have sanctioned the grant-in aid amount of Rs.17,31,54,000/- (General), Rs.10,04,29,000/- (SCP), Rs.7,27,25,000/- (TSP) respectively to the State towards the part payment of first installment of Central Share for implementation of National Rural Livelihoods Mission (NRLM)/ Ajeevika for the year 2019-2020 by Kudumbasree, Kerala SRLM. As per the letter read as 5<sup>th</sup> above, the Executive Director, Kudumbashree has requested to release the aforesaid Central Share received from Govt.of India along with the corresponding State Share for the above purpose.

In the circumstances, Government are pleased to accord sanction to release an amount of Rs.17,31,54,000/- (Rupees Seventeen Crore Thirty One Lakhs and Fifty Four Thousand only) as the Central Share (General Component), Rs.10,04,29,000/- (Rupees Ten Crore Four Lakhs and Twenty Nine Thousand only) as Central Share (SCP component) towards the first installment of Central Share for implementation of National Rural Livelihoods Mission (NRLM)/ Ajeevika for the year 2019-2020 by Kudumbashree, Kerala SRLM along with the corresponding State Share as detailed below:-
