ORDER

The DPC(H) held in the years 2018 & 2019 superseded Smt. Sathi T. I., Executive Engineer for promotion to the post of Superintending Engineer due to the prevalence of disciplinary action for minor penalty against her in connection with the irregularities in the construction of side protection wall and earth filling work in GHS, Kodungallur.

2. Later as per order no. E13/9682/2014/CE/LSGD dated 29.12.2018 of the Chief Engineer, LSGD, the above disciplinary action was finalised by exonerating from the charges levelled against the incumbent. Hence, she becomes eligible for promotion to the post of Superintending Engineer and accordingly the Review DPC(H) 2019 held on 10.07.2019, decided to place her as SI no.5(a) just above Smt. Jessy. E.S whose SI no. is 6 and Rank no.21 and just below Sri. Baburaj P. S. whose SI no. is 5 and Rank no.19 in the modified select list 2018 for promotion to the post of Superintending Engineer. Based on the DPC decision, the modified select list 2018 was notified vide GO read as 1st paper above. In the meantime, the incumbent retired from service on superannuation on 31.01.2019.

3. The Chief Engineer, LSGD, vide letter read as 2nd paper above, has reported that the immediate junior of Smt. Sathi T. I. in the modified select list, i.e., Smt. Jessy E. S. was promoted to the cadre of Superintending Engineer vide GO(Rt)No.2218/2018/LSGD dtd 09.08.2018. Hence, the Chief Engineer has proposed to promote Smt. Sathi T. I. notionally to the cadre of Superintending Engineer on 09.08.2018, i.e., w.e.f. date of promotion of her immediate junior.

4. Government have examined the matter in detail and are pleased to notionally promote Smt. Sathi T. I., Exc.Engineer (Rtd) to the cadre of Superintending Engineer, w.e.f the date of promotion of her immediate junior, i.e., 09.08.2018, without monetary benefit of back arrears of pay and allowances.
