ORDER

Ventokkumpadamparambu - Kuzhikalakulambu road was sanctioned under PMGSY-2008-2009 (Phase VII) Package No. KR 13-30 Pazhayannur Block, Thrissur District. As there occurred a delay in completing the work due to some land issues the Contractor filed his grievances before the Standing Empowered Committee requesting enhancement of rate. The Committee allowed rate enhancement for the balance work of Ventokumpadaparambu-Kuzhikalakulambu Road at 2012 SoR subject to the approval by the Finance Department. The Chief Engineer, KSRRDA has submitted the revised estimate, as per the letter read as 2nd paper above, for the hindered balance work at SoR 2012 amounting to Rs. 27, 85,543/- (Twenty Seven Lakh Eighty Five Thousand Five Hundred and Forty Three only) as endorsed by the Empowered Committee.

- 2. The Contractor also approached the Hon'ble High Court in the matter filing WP(C)No.15105/2019. As per the Judgment read as 3rd paper above the Hon'ble High Court has directed Government to take a decision on the revised proposal read as 2rd paper above.
- 3. Government have examined the matter in detail and are pleased to accord revised Administrative Sanction for the work of Ventokkumpadamparambu- Kuzhikalakulambu Road for the amount worked out by Chief Engineer at the value of works executed at agreed rates plus value of hindered works at revised rates fixed as per Government guidelines. The Chief Engineer, KSRRDA should ensure that the revised item rates for hindered works will be least of SoR & LMR prevailed at the time of initiating the proposal only.
- 4. The Chief Engineer, KSRRDA is directed to take steps to release the amount due to the Contractor at the earliest and at any rate, within three months.
- 5. The directions contained in the Judgement read as 3rd paper above is thus complied with.
