**ORDER**

Government of India vide letter read as 1<sup>st</sup> paper above have released an amount of Rs.36,07,77,000/- (Rupees Thirty Six Crore Seven Lakh and Seventy Seven Thousand Only) to the State Government of Kerala as the 3<sup>rd</sup> instalment of 1<sup>st</sup> tranche of central assistance towards material and administrative contingency for implementation of MGNREGA for the financial year 2019-20. As there was no component-wise bifurcation for this release, the Mission Director(MGNREGS) vide letter read as 2<sup>nd</sup> paper above submitted a proposal for release of central share received along with the corresponding state share as per the necessity.

Government have examined the matter in detail and are pleased to accord sanction for releasing an amount of **Rs.36,07,77,000/-** (Rupees Thirty Six Crore Seven Lakh and Seventy Seven Thousand Only) being the 3<sup>rd</sup> instalment of 1<sup>st</sup> tranche of Central Assistance received towards material and administrative components for implementation of MGNREGA for the financial year 2019-20 and an amount of **Rs.7,52,59,000/-**(Seven Crore Fifty Two Lakh Fifty Nine Thousand only)- being the corresponding State Share towards


material component for the financial year 2019-20 as detailed below.
