ORDER

The procedures and guidelines for planning and execution of KIIFB assisted infrastructure projects by the various Special Purpose Vehicles are issued as per Government Orders read as first and third paper above. As per the Government Order read as second paper above a Special Purpose Vehicle (IMPACT KERALA Ltd) was constituted for implementing major infrastructure projects of Local Self Government Department with the assistance of KIIFB. In the Kerala Budget 2017-18 (para 146) an amount of Rs 100 Crore has been earmarked for modernization of selected markets utilizing financial assistance from KIIFB.

2) As per the letter read as fourth paper above, Managing Director, IMPACT KERALA has submitted a concept note for issuing administrative sanction for Modernisation of selected Markets in various Local Self Government Institutions of Kerala for a total amount of Rs. 100 Crore utilizing financial assistance from KIIFB.

3) Government have examined the matter in detail and are pleased to accord administration sanction for the project, ' Modernization of Selected Markets in Various Local

Self Government Institutions in Kerala' by entrusting IMPACT Kerala Ltd as Special Purpose Vehicle for the work subject to the condition that all the procedures and guidelines for planning and execution of KIIFB assisted infrastructure projects by the various SPVs issued as per Government Order read as first and third paper above should be scrupulously followed.
