## ORDER

Accordingly, the select list was published as per the Government Order read as 3<sup>rd</sup> paper above, by fixing the seniority of Shri.Latheshkumar V.V. in the cadre of Municipal Secretary Grade II in between Shri.Saji S.S. (Sl.No. 10) and Shri.Sreekanth A.S. (Sl.No.11). His immediate junior Shri. Sreekanth A.S was promoted to the cadre of Municipal Secretary Grade II as per the Government Order read as 1<sup>st</sup> paper above.

In the order read as 2<sup>nd</sup> paper above, the Hon'ble Kerala Administrative Tribunal disposed of the OA with a direction to the first respondent (State of Kerala represented by Additional Chief Secretary, Local Self Government Department) to take a decision on Annexure A10 representation within a period of three months from the date of receipt of a certified copy of the order.

3. Government have examined the matter in detail and are pleased to grant notional promotion to Shri.Latheshkumar V.V. to the post of Municipal Secretary Grade II w.e.f. 10.05.2017, the date on which his immediate junior, Shri.Sreekanth A.S. was promoted.
