ORDER

The 22nd State Level High Powered Steering Committee (SHPSC) of AMRUT chaired by Chief Secretary held on 25.10.2019 has approved the proposal of providing new water connections (including Water Meter) to 4950 houses under the Water Supply Sector of AMRUT in Kannur Corporation at an estimated cost of Rs. 2.92 Crore utilizing the fund from the savings of Water Supply Sector SAAP I i.e. Rs. 2.50 Crore from the project, "Laying Gravity Main from GICA Project at Mangattuparampa to Pallikkunnu OHSR" and savings of Rs. 3.39 Crore from the Storm Water Drainage Sector (SAAP III) and Rs. 3.72 Crore from the savings from the Urban Transport Sector (SAAP II).

- 2) The 22nd State Level High Powered Steering Committee has also decided to accord Administrative Sanction for the work " 50 KLD Sewage Treatment Plant and Associated Networks at Thottumadi Colony" under Septage/Sewerage Sector of AMRUT in Alappuzha Municipality for an amount of Rs. 2.24 Crore utilizing the savings in Septage/Sewerage Sector -SAAP III and 4 Storm Water Drainage Works in Alappuzha Municipality amounting to Rs. 1.28 Crore utilizing the savings from the completed works .
- 3) Government have examined the matter in detail and pleased to accord administrative sanction to the following works under AMRUT as approved by the State Level High Powered Steering Committee of AMRUT held on 25.10.2019, subject to the conditions noted against each.
