## <u>ORDER</u>

per the Government Order read as 2nd paper above, Dr. VaisakhT.P. and Dr. Gopika Gopalakrishnan were posted as Health Officers (Grade III) in the scale of pay of Rs.20,740-36,140 (PR) in Municipal Common Service at Thalassery Municipality/ Kollam Corporation respectively.

- 2. Dr. Vaisakh T.P. has submitted a representation as per the letter read as 3rd paper above stating that he is undergoing a two year training programme (Epidmic Intelligence Services) conducted by National Centre for Disease Control, Delhi and that he has joined the training on 14.01.2019 and it will be completed only on 13.01.2021. Hence, he has requested for extension of joining time upto 13.01.2021.
- 3. Dr.Gopika Gopalakrishnan has submitted representation as per the letters read as 4th paper above stating that she is working as Senior Resident on one year bonded obligation at Government Medical College, Kollam and she

has requested for extension of joining time upto 22.12.2019.

- 4. As per Sl.No. (3) of Circular read as 1<sup>st</sup> paper above joining time beyond 45 days can be granted by the Government to those candidates who are in the midst of any educational course or undergoing any training, so as to enable them to complete the course/training and then to report for duty.
- 5. Government have examined the matter in detail and are pleased to grant extension of joining time upto 13.01.2021 to Dr. Vaisakh T.P., who is undergoing training and upto 22.12.2019 to Dr. Gopika Gopalakrishnan who is under bonded obligation as part of her PG course subject to the condition that the date of the appointment shall be determined by the date of their joining duty.
  - 6. Further extension of joining time will not be allowed on any account.
