**ORDER**

As per the letter read as 2<sup>nd</sup> paper above, Government of India sanctioned an amount of Rs.18.06 Crore under General, SCP and TSP components of the ongoing project under MKSP for collective farming through women groups in all the District of Kerala, implemented by the SRLM Kudumbashree. Government of India have credited the central share through RTGS to Kudumbashree.

2.As per the Government Order read as 3<sup>rd</sup> and 4<sup>th</sup> paper above, sanction was accorded for the release of an amount of Rs.12.04 Crore instead of Rs.13.95 Crore towards the 2<sup>nd</sup> installment of state share under General, SCP and TSP components. Now the Executive Director, Kudumbashree as per his letter read as 5<sup>th</sup> paper above has requested to release the balance amount of Rs.1.91 Crore from the current years Budget allocation.

3. After having examined the matter in detail, Government are pleased to accord sanction to release the balance amount of State Share Rs.1,91,00,000/- (Rupees One Crore and Ninety One Lakhs Only) of 2<sup>nd</sup> installment under MKSP for collective farming through women groups, implemented in Kerala by the SRLM-Kudumbashree for the year 2015-16 under General, SCP and TSP components from the current year's budget allocation as detailed below:-
