ORDER

As per the instructions issued by the Ministry of Housing & Urban Affairs, GoI, all SPVs of the Smart Cities shall register in the P.F.M.S. and roll out of Expenditure, Advance and Transfer (EAT) Module for complete digitization of Government's financial transactions. As per the requirements of P.F.M.S. the SPVs of Smart Cities shall be placed under a State Implementing Agency, in order to complete the compliance of P.F.M.S. Therefore the Chief Executive Officer, Smart City Thiruvananthapuram Ltd., as per the letter read as 2nd paper above has requested to place the Smart City Projects under the State Implementing Agency, State Mission Management Unit (SMMU) Kerala.

- 2. Government have examined the matter in detail and are pleased to place Smart City Projects of Kochi and Thiruvananthapuram under the State Implementing Agency, SMMU Kerala for financial transactions in order to complete the compliance of P.F.M.S. The transfer of funds for Smart City Projects shall be made through the State Implementing Agency, SMMU Kerala to the P.F.M.S. linked Bank Account of Smart City Thiruvananthapuram Ltd. (SCTL) and Cochin Smart Mission Ltd. (CSML).
