### ORDER

The first phase of the Kerala Local Government Service Delivery Project (KLGSDP) was completed on 29th December 2017 and in order to continue the effective completion of the various initiatives in the first phase of the KLGSDP, Government vide Order read as first paper above, have approved the Concept Note for the 2nd phase of Kerala Local Government Service Delivery Projects and as per Government Order read as second paper above, have approved the Project Preliminary Report of the Kerala Local Government Service Delivery Project, phase 2, subject to the condition that that it shall be part of Development fund being provided to LSGIs and not above it.

2. Considering the proposal forwarded by the Screening Committee, the World Bank has accepted the project report and has offered a loan of 300 million USD for the second phase of KLGSDP, which was envisaged to strengthen the institutional capacity of all Urban Local Bodies and to provide additional support in Waste Management, Septage and Sewage management and Sanitation Sector.

3. The Project Director, as per note read above, has requested to release the funds of KUSDP as additional amount on top of the yearly annual allocation to the Urban Local Bodies, as it is the need of hour to address the concerns of Waste Management and Sanitation.


