**ORDER**

As per the G.O. read as 1<sup>st</sup> paper above, Government have accorded sanction to the Executive Director, Kudumbashree to nominate 2 teams of 20 participants of Urban Local Bodies and technical cell members of PMAY (U) for the training and exposure visit to Tripura and Madhya Pradesh, subject to the condition that the travelling expenses in connection with the visit shall be met from the Administrative Cost of PMAY(U), as per the eligibility of the participants.

2. As per the letter read as 2<sup>nd</sup> paper above, the Executive Director, Kudumbashree has informed that as per the norms of Ministry of Housing & Urban Affairs, the TA for the exposure visit should be borne by the concerned Departments/Organizations. A&OE fund of PMAY(U) is limited to the administrative expenses related to the implementation of PMAY(U) Mission alone, subject to the condition that A&OE and Geo-tagging expenses should not exceed 1% of the ACA released by the Ministry. Therefore the Executive Director, Kudumbashree has requested to accord sanction to meet the travelling expenses for the exposure visit from the own fund of Urban Local Body itself, as per eligible TA norms.

3. Government have examined the matter in detail and pleased to accord sanction to meet the travelling expenses for the exposure visit from the own fund of Urban Local Body itself, as per eligible TA norms.

4. The G.O read as 1<sup>st</sup> paper above stands modified to the above extent only.
