In the Annexure A10 representation, the applicant has requested to refix his seniority and to grant him notional promotion to the post of Municipal Secretary Grade II with effect from 10.05.2017 and to the post of Municipal Secretary Grade I with effect from 14.06.2018, the dates from which Shri.Sreekanth A.S., his immediate junior was promoted.
- 3. Government have examined the matter in detail and as per the Government Order read as 2nd paper above, Shri.Latheshkumar V.V. was granted notional promotion to the post of Municipal Secretary Grade II w.e.f 10.05.2017 and as per the Government Order read as 3rd paper above, notional promotion was granted to him to the post of Municipal Secretary Grade I w.e.f 14.06.2018.

4. Hence, the order dated 09.10.2018 of the Hon'ble Kerala Administrative Tribunal in OA (EKM) No.1894/18 filed by Shri.Latheshkumar V.V. has been complied with.
