As per letter read as 1st paper above Government of India have sanctioned 1st Instalment of Central Share amounting to ₹19,39,00,000/-(Rupees Nineteen Crore Thirty Nine Lakh only) for implementation of projects under Watershed Development Component of Pradhan Mantri Krishi Sinchayee Yojana (WDC-PMKSY) in Kerala during the financial year 2019-20. Corresponding State Share (40%) comes to ₹12,92,70,000/- (Rupees Twelve Crore Ninety Two Lakh Seventy Thousand only). As per the letter read as 2nd paper above, the Commissioner for Rural Development Department has submitted proposal for the release of the aforesaid Central Share and the corresponding State Share.
