Local Self Government Department - Establishment - Case against Shri.S. Jayakumar, former Secretary, Adoor Municipality and others Prosecution sanction - Orders issued.

ORDER

WHEREAS it has been disclosed from the records of investigation in VC 04/2011/PTA of Vigilance & Anti Corruption Bureau Police Station, Pathanamthitta that Shri. S. Jayakumar, residing at No. 616, Lakshmi Gardens, Kanjiramkulam, Thiruvananthapuram while working as Secretary, Adoor Municipality from 22.11.2008 to 27.08.2009 and as such being public servant, conspired with Shri S. Shajahan, S/o Shri.Shahul Hammed, Ushara Manzil, Kannamcode, Adoor Village while working as Municipal Councilor, Adoor Municipality and Shri Muhammed Badushan, S/o Shahul Hameed Rawther, Koippally Thazhethil House, Kannamcode, Adoor during March 2009 and pursuant to the said conspiracy, the said persons have caused the destruction of the forged consent letter and application for the cancellation of D& O licence from being produced before the Ombudsman for Local Self Government Institution in connection with the proceedings in OP No. 1157/08 and OP No. 1051/08. The actions of Shri.SJayakumar has caused to obtain valuable thing to Shri.Shajahan preparing forged consent letter by Shri.S.Shajahan in the name of Karthiyayani Amma Rajamma (the late) for the issuance of D&O licence in favour of Shri.Muhammed Badushan to run a fruit stall in the premises of Karthiyayani Amma Rajamma (the late) and thereby committed criminal misconduct and offences under PC Act, 1988 and IPC 1860.

AND WHEREAS the above said actions on the part of the said Shri.S.Jayakumar, amount to offences punishable under section 13(1) (d) r/w, section 13(2) of PC Act and Section 204, 120-B IPC &34 IPC and the actions on the part of Shri. S. Shajahan and Shri. Muhammed Badusha

amount to offences punishable under section 465, 468, 471, 420 r/w 511, Sec 204, 120-B IPC & 34 IPC.

AND WHEREAS the Government of Kerala being the authority competent to remove the said Shri. S. Jayakumar, from office, after fully and carefully examining the materials before it in regard to the said allegations and circumstances of the case and after applying its mind consider that the said Shri. S. Jayakumar should be prosecuted in a court of law for the said offences.

NOW THEREFORE, the Government of Kerala do hereby accord sanction required under Section 19(1) (b) of the Prevention of Corruption Act, 1988 for the prosecution of Shri.S. Jayakumar for the said offences and any other offences punishable under other provisions of law in respect of the aforesaid acts and for the taking of cognizance of the said offences by a court of competent jurisdiction.
