ORDER

As per the GO read as 1st paper above, State Government released a total amount of Rs.27.00 crore towards the 1st installment under National Rurban Mission Phase III for the 3 clusters identified by the Government of Kerala and approved by the Central Government. Since the fourth cluster was not approved, the 1st installment of fund for that cluster was not released.

- 2) As per the letter read as 2nd paper above, Central Government given approval for the 4th cluster identified by the Government of Kerala, namely, Pinarayi-Vengad Cluster in Kannur District and the letter read as 3rd above, MoRD released an amount of Rs.5.40 crore being the balance of 1st installment of Central share for National Rurban Mission Phase III. Since the funding pattern of the scheme is 60:40, the corresponding state share will be Rs.3.60 crore.
- 3) The Commissioner for Rural Development as per the letter read as 4th paper above, has requested Government to accord sanction for releasing the aforesaid Central share along with corresponding State share and to transfer credit the amount to the Plan Scheme Treasury Savings Bank Accounts (PSTSB) maintained by Commissioner at District Treasury, Thiruvananthapuram.

4) Government have examined the matter in detail and are pleased to accord sanction for releasing a total amount of Rs.9 Crore as balance of 1st installment of Central share and its corresponding State Share under National Rurban Mission (NRum) Phase III, as detailed below.
