ORDER

Government of India vide letter read as 1st paper above have released an amount of Rs.27,77,62,000/- (Rupees Twenty Seven Crore Seventy Seven Lakh and Sixty Two Thousand Only) to Government of Kerala, being the 4th installment of 1st tranche of Central assistance towards material and administrative contingency for implementation of MGNREGA for the financial year 2019-20. Out of this allotment, Rs.27,00,00,000/- (Rupees Twenty Seven Crore only) is towards administrative component and Rs.77,62,000/- (Seventy Seven Lakh Sixty Two Thousand Only) is towards material component. The Mission Director (MGNREGS) vide letter read as 2nd paper above submitted a proposal for release of central share received along with the corresponding state share.

Government have examined the matter in detail and are pleased to accord sanction for releasing an amount of Rs.27,77,62,000/- (Rupees Twenty Seven Crore Seventy Seven Lakh and Sixty Two Thousand Only) being the 4th installment of 1st tranche of Central Assistance received towards material and administrative components for implementation of MGNREGA for the financial year 2019-20 along with the corresponding state share of Rs.25,87,000/-(Rupees Twenty Five Lakh Eighty Seven Thousand only)- towards material component for the financial year 2019-20 as detailed below.
