ORDER

"St.Martin Nariyandi Junction Road" under Package No- KR-01-65, Pattanakkad Block, Alappuzha District is one among the 84 road works sanctioned by the Government of India under Phase -II, Batch-1 of PMGSY, for an amount of Rs.141.71 lakh. The work was technically sanctioned for Rs.1,40,91,101/-. But the Chief Engineer, KSRRDA has reported as per the letter read as 2nd paper above that there was no response (or single tender) from the contractors to the initial 7 tender/retender notices. On the eighth occasion of retendering the work, a single bid was received from a contractor viz, P.K.Constructions, Kooliyadans Building, Market Road, Trippunithura, who has quoted a rate which is 25% above the estimate rate.

- 2. As per the directions contained in the Government Order read as 1st paper above, a Tender Committee was constituted and the Committee, after comparing the quoted rate with that of the LMR and DSR rate, decided to recommended the tender excess at a rate of 25% above SOR 2013, which is the lower rate quoted by the contractor. In the circumstances, the Chief Engineer, KSRRDA has requested permission to award the work at the rate of 25% above SOR 2013 and also for an additional fund of Rs.34,28,416/(Rupees Thirty Four Lakh Twenty Eight Thousand Four Hundred and Sixteen only) for the work.
- 3. Government have examined the matter in detail and are pleased to accorded sanction an additional fund of Rs.34,28,416/- (Rupees Thirty Four Lakh Twenty Eight Thousand Four Hundred and Sixteen only) for the
