#### **ORDER**

As per letter read as 1st paper above Ministry of Rural Development, Government of India have released an amount of ₹95,25,000/-(Rupees Ninety Five Lakh Twenty Five Thousand only) as 1st installment of Administrative funds to the Government of Kerala under PMGSY for the year 2019-20. As the funding pattern between Central and State Government under PMGSY is 60.40, State Government has to release matching State Share of ₹63,50,000/- (Rupees Sixty Three Lakh Fifty Thousand only). As per the letter read as 2nd paper above, the Member Secretary, KSRRDA has submitted proposal for the release of the aforesaid Central Share and corresponding State Share under the H/A 2515-800-74-01 and 2515-800-74-02 respectively.

2) In the above circumstances, Government are pleased to accord sanction for releasing ₹95,25,000/- (Rupees Ninety Five Lakh Twenty Five Thousand only) as Central Share of 1st instalment of Administrative funds under PMGSY for the year 2019-20 along with its matching State Share ₹63,50,000/- (Rupees Sixty Three Lakh Fifty Thousand only) by debiting the expenditure under the H/A 2515-800-74-01 and 2515-800-74-02 respectively and to transfer credit the amount to the PSTSB Account No.799012700000447 of the Commissioner for Rural Development and Member Secretary, KSRRDA at District Treasury,
