ORDER

Thiruvananthapuram Mayor has informed Life Mission as per letter read as 2nd paper above that 50 cents of land is available for construction of LIFE towers in Karimadom colony and in the colony, 560 dwelling unit are proposed to built under BSUP scheme. And of which, 320 units has been completed and 112 units are under construction. In BSUP the plinth area unit is 40.30m2 and it has one bedroom, multipurpose hall, kitchen, toilet cum bath and a balcony/ verandah. While in the LIFE Mission project the 46.45m² has, 2 bedrooms, a hall, kitchen, balcony and separate toilet & bath. As implementing dwellings of differing facilities may cause social issues among the residents of the colony, the Mayor has requested to give sanction to Thiruvananthapuram Corporation to take forward LIFE Tower project of executing 52 dwelling units comprising of 20units of 37.75m² and 32units of 40.01 m² instead of 44 dwelling units at a maximum estimated cost of Rs.462 Lakhs. Chief Executive Officer, LIFE Mission has informed that Karimadom slum colony is in the centre of the city and rehabilitation of the residents from the dilapidated shanties underway by the corporation to be the deviation request made by the Corporation can facilitated. consider favourably
