### **ORDER**

Government of India, vide letter read as 1<sup>st</sup> paper above, have released an amount of Rs.5,00,00,000/- (Rupees Five Crore only) to the State Government of Kerala being the 5<sup>th</sup> installment of 1<sup>st</sup> tranche of Central Assistance towards Material and Administrative Contingency for implementation of MGNREGA for the financial year 2019-20. The Mission Director (MGNREGS), vide letter read as 2<sup>nd</sup> paper above, has submitted a proposal for release of Central Share received along with the corresponding State Share. The component-wise bifurcation proposed by the Mission Director is based on the requirement.
