ORDER

Government of India vide letter read as 1st paper above have released an amount of Rs.9,37,12,000/- (Rupees Nine Crore Thirty Seven Lakh and Twelve Thousand only) being the 6th installment of 1st tranche of Central Assistance towards Material and Administrative contingency for implementation of MGNREGA in the State for the financial year 2019-20. The Mission Director (MGNREGS) vide letter read as 2nd paper above, has submitted a proposal for release of Central Share received along with the corresponding State Share. As there was no component-wise bifurcation for the Central release, the Mission Director submitted the proposal based on requirement.

Government have examined the matter in detail and are pleased to accord sanction for releasing an amount of Rs.9,37,12,000/- (Rupees Nine Crore Thirty Seven Lakh and Twelve Thousand only) being the 6th installment of 1st tranche of Central Assistance received towards Material and Administrative components for implementation of MGNREGA for the financial year 2019-20 along with its matching State Share of Rs.2,95,70,000/- (Rupees Two Crore Ninety Five Lakh Seventy Thousand only) towards material component for the financial year 2019-20 as detailed below;
