ORDER

As per GO (P) no.85/2011/Fin dtd 26.02.2011, ratio based Higher Grade Promotion was introduced in the cadre of Executive Engineer in the LSGD Engg Wing for the first time so that 25% of the posts in Higher Grade will be in the pay scale of Rs 40640-57440 w.e.f 01.02.2011. Accordingly Government had sanctioned ratio based Higher Grade promotion to 25 Executive Engineers, excluding Sri. Ananda Raju for want of declaration of probation in Executive Engineer cadre, though he was otherwise found eligible w.e.f 01.02.2011, vide GO read as 2nd paper above.

2. Now, the probation of Sri. Ananda Raju in the Executive Engineer cadre has been satisfactorily declared w.e.f 15.02.2008 FN vide GO(Rt)no. 2429/2019/LSGD dated 02.11.2019. Accordingly, the Chief Engineer, vide letter read above, has proposed to grant ratio based Higher Grade promotion to the incumbent w.e.f 01.02.2011.

3. Eleven Executive Engineers among the 45 Executive Engineers in the Department as on 01.02.2011 were found eligible for ratio based Higher Grade promotion w.e.f the same date, but only 8 eligible Executive Engineers were granted the same benefit and three Executive Engineer Higher Grade positions, including that of Sri. Ananda Raju were kept vacant. Therefore, he is eligible for ratio based Higher Grade promotion in the Executive Engineer cadre w.e.f 01.02.2011, pursuant to the declaration of his probation in Executive Engineer cadre.

4. In the above circumstances, Sri. Ananda Raju. B, Executive Engineer (Rtd) is granted ratio based Higher Grade promotion in the Executive Engineer cadre w.e.f 01.02.2011 in the pay scale of Rs 40640-57440 as per GO read as 1st paper above.
