ORDER

As per G.O read as 1st paper above, an amount of Rs.171.84 Lakhs has been sanctioned to District Collector, Idukki for the purpose of removing the waste spread over the agriculture land of a private individual from the dumping yard of Kumiliy Grama Panchayat due to heavy rain and flood during 2018 and transferring the same to Kerala Enviro Infrastructure Ltd (KEIL), Ambalamukal for safe land filling. Accordingly the District Collector, Idukki has entrusted Clean Kerala Compnay Ltd (CKCL) to transfer the waste from Kumily to KEIL, Ambalamukal.

2. Clean Kerala Company Ltd. has removed the flood waste from the land and sent to Kerala Enviro Infrastructure Ltd (KEIL) Ambalamughal, Kochi for safe disposal by hiring a transport contractor following tender process. As per the letter read as 2nd paper above, Managing Director, Clean Kerala Company Ltd has reported that, the District Collector, Idukki has sanctioned an amount of Rs 34,19,117/- to Clean Kerala Company Ltd for the work,

but the payment was not effected due to treasury restrictions. It is also reported that, due to the delay in getting funds, CKCL has paid a sum of Rs 15/- lakh from their own fund to KEIL. Managing Director Clean Kerala Company Ltd has requested to grant permission to pay the balance amount of Rs. 19,19,117/- to Kerala Enviro Infrastructure Ltd (KEIL) Ambalamughal, Kochi towards the disposal of the flood waste accumulated in the private agricultural land in Idukki, from the corpus fund of CKCL, subject to the ratification of the Board of Directors.

3. Government have examined the matter in detail and are pleased to accord sanction to Clean Kerala Company Ltd. to pay an amount of Rs. 19,19,117/-, the balance amount to be paid to Kerala Enviro Infrastructure Ltd (KEIL) Ambalamughal, Kochi towards the disposal of the flood waste accumulated in the private agricultural land in Idukki, from the corpus fund of Clean Kerala Company Ltd., subject to the ratification of the Board of Directors. Managing Director, Clean Kerala Company Ltd shall ensure that the funds are recouped when treasury restrictions are lifted.
