As per the G.O read as 1st paper above, Administrative Sanction was accorded for the project "Rehabilitation of existing old pipes, valves & interconnections with existing lines Phase-II" in Kozhikode Corporation for an amount of Rs 14.63 Cr.

The Mission Director AMRUT in his letter read as third paper above has informed that, for the aforesaid work an excess amount Rs. 0.869 Cr is required due to tender excess and revised road restoration charges and hence requested Government to issue revised administrative sanction for the project for Rs 15.499Cr. The 23rd State Level High Powered Steering Committee(SPSC) of AMRUT held on 04/02/2020 has approved revision of Administrative sanction for the aforesaid work subject to the approval of Corporation Council
