#### ORDER

The Hon'ble Kerala Administrative Tribunal, as per its order read as 1 st paper above, has disposed of OA(EKM) 276/2020, with a direction to the Ist respondent, the Govt, to consider and pass appropriate orders on Annexure A7 representation, read as 2<sup>nd</sup> paper above, within a period of 3 months from the date of receipt of a copy of the order. It is also directed therein to revise the pensionary benefits of the applicant and to disburse the arrears, if any, without further delay, on sanctioning the higher grade. The request of the applicant is to sanction and disburse the monetary benefit of Executive Engineer (HG) w.e.f. 01.02.2011.

- 2. The proposal for granting ratio based higher promotion to Sri. Ananda Raju B., submitted by the Chief Engineer, LSGD pursuant to the declaration of his probation in Executive Engineer cadre was examined in detail and he was sanctioned with the benefit w.e.f 01.02.2011, in the pay scale of Rs 40640-57440, vide GO read as 3<sup>rd</sup> paper above. Accordingly, the Chief Engineer is hereby directed to revise the pensionary benefits and to disburse the arrears, if any, to the applicant pursuant to the sanctioning of ratio based higher grade promotion.
