**ORDER**

The 15<sup>th</sup> Finance Commission has recommended an amount of ₹445 crore consisting of two equal parts – 50% basic grants and 50% tied grants for Urban Local Bodies other than Non-Million Plus cities for the year 2020-21.

2) As per Government Order read as 3<sup>rd</sup> paper above, Finance Commission Grant has to be authorized to Local Governments for expenditure only on receipt of the same from Government of India. But due to the request of Local Governments, 20% of the Basic Grant amounting to ₹97,60,49,000/- vide Government order read as 4<sup>th</sup> paper above, has been authorized to Non-Million Plus cities to clear the bills in the Treasury queue.

3) As per letter read as 5<sup>th</sup> paper above, Government of India have released an amount of ₹111.25 crore as 1<sup>st</sup> installment of Untied Basic Grant under 15<sup>th</sup> Finance Commission Award to Non-Million Plus cities for the year 2020-21 and requested the State to make allotment of grants on population basis to Cantonment Boards. An amount of ₹13,64,51,000/- has to be authorized as balance amount of 1<sup>st</sup> installment of Untied Basic Grant under 15<sup>th</sup> Finance Commission Award to Non-Million Plus cities including Cannanore Cantonment Board.

4) As per letter read as 6<sup>th</sup> paper above, the Mukhya Adhishashi Adhikari has forwarded the Bank Account details and requested to transfer credit the ULB Grant to

Cannanore Cantonment Board. The grant to Cantonment Board is calculated to be ₹12,07,225/-

5) Government, after having examined the matter in detail, are pleased to authorize an amount of ₹13,52,43,775/- (Rupees Thirteen crore Fifty Two lakh Forty Three thousand Seven hundred and Seventy Five only) to 86 Non-Million Plus cities as balance amount of 1<sup>st</sup> installment of Untied Basic Grant under 15<sup>th</sup> Finance Commission Award and to accord sanction to transfer credit a sum of Rs.12,07,225 (Rupees Twelve lakh Seven thousand Two hundred and Twenty Five only) to Cannanore Cantonment Board as 1<sup>st</sup> installment of Untied Basic Grant under 15<sup>th</sup> Finance Commission Award complying the release order issued by Government of India as detailed below:


