ORDER

As per Government Orders read as 1st and 2nd papers above, sanction was accorded for releasing amounts of ₹6,50,00,000/- and ₹12,32,82,000/- respectively, being the 5th and 6th installment of 1st tranche of Central assistance received and the corresponding State share for implementation of Mahatma Gandhi NREGS in the State for the FY 2019-20.

- 2. As per the letter read as 4th paper above, the Mission Director (MGNREGS) has reported that when the Commissioner for Rural Development submitted the bills to draw the amounts, bills except for Rs.50 lakh were not cleared in the FY 2019-20. Hence the Mission Director has requested Government to issue fresh release orders for the balance amount of ₹18,32,82,000/-, so as to draw the amounts in the current financial year.
- 3. Government have examined the matter in detail and are pleased to re-validate the releasing orders issued as per Government Orders read as 1st and 2nd paper above. The Commissioner for Rural Development Department is authorised to transfer credit the withheld amounts as detailed below to the State Employment Guarantee Fund (SEGF) of MGNREGS immediately by debiting the expenditures from the Budget provisions available in the heads of accounts concerned for the current financial year.
