ORDER

As per the Government Order read as 1st paper above sanction was accorded for the release of an amount of ₹3,64,84,667/- and (SCP Component), ₹2,70,86,000/- (TSP Component) respectively to Kudumbashree towards the third installment of State share under National Rural Livelihood Mission (NRLM) for the financial year 2018-19.

As per the Government order read as 2nd paper above, sanction was also accorded for the release of an amount of ₹6,69,52,667/- (SCP Component) towards the first installment of State share under National Rural Livelihood Mission (NRLM) for the year 2019-20.

2) As per the letter read as 3^{rd} paper above the Ministry of Rural Development, GOI have sanctioned an amount of $\mathbb{Z}7,27,25,000$ /- (TSP Component) towards first installment of Central share under National Rural Livelihood Mission (NRLM) for the year 2019-20. While issuing the Government order read as 2^{nd} paper above, Government have not released the Central share of $\mathbb{Z}7,27,25,000$ /- as well as the corresponding State share of $\mathbb{Z}4,84,83,333$ /- due to the the non availability of sufficient fund in the Head of

- 3) Now the Executive Director, Kudumbashree, as per his letter read as 4th paper above, has requested to accord Administrative Sanction to release the Central and State Share of TSP Component for the year 2019-20 and the State share of SCP and TSP Component for the year 2018-19 from the current year's Budget provision.
- 4) After having examined the matter in detail, Government are pleased to accord sanction to release a total amount of ₹25,17,31,667/- towards the Central and State Share of TSP Component for the year 2019-20 and the State share of SCP and TSP Components for the year 2018-19 from the current year's Budget provision as detailed below:
