The interim order dated 11.03.2020 in MA(EKM) 397/2020 in OA(EKM) 1268/2018 filed by Smt. A.S. Anuja, Corporation/Additional Corporation Secretary.

ORDER

The Hon'ble Kerala Administrative Tribunal as per the interim order read above has directed the first respondent (State of Kerala represented by Secretary, LSGD) to take a decision on Annexure MA 1 representation submitted by Smt. A.S. Anuja, Corporation/Additional Corporation Secretary, Kollam corporation for considering the plea for grant of provisional promotion as expeditiously as possible at any rate with in a period of three weeks from the date of receipt of a copy of the

order.

As per the MA 1 representation Smt. A.S. Anuja has requested to promote her to the post of Joint Director of Urban Affairs with effect from 01.10.2016, the date on which the first vacancy was reported in the post of Joint Director and to review the decision of DPC(H) held on 14.01.2019 and 02.09.2019 and to grant provisional promotion to the post of Joint Director of Urban Affairs. Smt. A.S. Anuja is due to retire from service on superannuation on 31.05.2020.

The DPC (H) met on 02.09.2019 observed that the currency of the penalty imposed by barring one annual increment for one year without cumulative effect as per G.O.(Rt) No.802/2019/LSGD dated 04.04.2019 expires only on 03.04.2020 and hence decided that she can be considered for inclusion in the select list only after 03.04.2020. At present no disciplinary action is pending against the applicant and the currency of punishment awarded as per G.O.(Rt) No.802/2019/LSGD dated 04.04.2019 expired on 03.04.2020.

The DPC (H) of the Urban Affairs Department for the preparation of select list for 2020 for promotion to various posts has not been convened yet. Hence, there is no select list in force for promotion to the post of Joint Director in Urban Affairs Department.In Circular No.5328/Rules-1/99/P&ARD dated 03.06.1999, it is stated that where the incumbents are to retire within a period of six months and where there is not a large number of seniors to be promoted, promotions may be given in relaxation of the ban on provisional promotion.

Smt.A.S.Anuja is the senior officer in the cadre of Corporation/Additional Corporation Secretary in the Urban Affairs Department, who is due to retire from service on superannuation on 31.05.2020. Hence, it seems that she is to be considered for temporary

promotion to the post of Joint Director in Urban Affairs Department, as per Rule 31(a)(i) of Part I of KS&SSRs.

Government have examined the matter in detail . The DPC (H) met on 02.09.2019 observed that the currency of the penalty imposed by barring one annual increment for one year without cumulative effect as per G.O.(Rt) No.802/2019/LSGD dated 04.04.2019 expires only on 03.04.2020 and hence decided that she can be considered for inclusion in the select list only after 03.04.2020. At present no disciplinary action is pending against the applicant and the currency of punishment awarded as per G.O.(Rt) No.802/2019/LSGD dated 04.04.2019 expired on 03.04.2020. At present there is no vacancy of Joint Director in the Department of Urban Affairs and hence the junior most Joint Director is to be reverted to promote the incumbent . In the circumstances Government are pleased to grant temporary promotion, with immediate effect, to Smt. A.S. Anuja, Corporation/Additional Corporation Secretary, to the post of Joint Director in Urban Affairs Department and posted as Regional Joint Director, Kochi by reverting the junior most Joint Director Smt. Anu R.S, Regional Joint Director, Kochi to the post of Corporation/Additional Corporation Secretary, in compliance with the interim order of the Hon'ble Kerala Administrative Tribunal dated 11.03.2020 in MA (EKM) 397/2020 in (EKM)1268/2018 filed by Smt. A.S. Anuja. Corporation/Additional Corporation Secretary, Kollam Corporation. The posting order of Smt. Anu R.S Corporation/Additional Corporation Secretary will be issued separately.
