ORDER

Sri. Sulfikkar N., Sri. Joy Ashok, Sri. P. J. Thankachan and Sri. Srinivasan C., Assistant Executive Engineers have filed OA(EKM) no.579/2020 before the Hon'ble KAT praying for a direction to provisionally promote them as Executive Engineers in the vacancies kept vacant in the department for implementing final orders of the Hon'ble Supreme Court dated Civil Appeal nos.6165/2017.

In view of the retirement of Sri. Joy Ashok due on 31.05.2020, the Hon' KAT as per its interim order read as 1st paper above, directed the respondents to pass appropriate orders promoting the applicants to the post of Executive Engineer provisionally on production of a copy of the interim order at any rate before 30.05.2020, subject to further orders of the Tribunal to be passed in the OA.

Pursuant to the above interim orders of the Hon'ble KAT, the Chief Engineer, vide the paper read as 2nd above, has requested that the said four Assistant Executive Engineers be provisionally promoted as Executive Engineers subject to the final orders of the Hon'ble KAT.

Government have examined the matter in detail and the following provisional promotions under Rule 31 (a) (i) of Part II of KS&SSRs, 1958 are ordered to the post of Executive Engineer in the scale of pay of Rs 68,700 – 1,10,400/-, subject to the final orders of the Hon'ble KAT in this case, in order to comply with the Court direction read as 1st paper above.

i. Sri.Sulfikkar N., Assistant Executive Engineer, Vengara Block, Malappuram is provisionally promoted to the post of Executive Engineer and is posted as such in LSGD South Circle, Thiruvananthapuram.

ii. Sri. Joy Ashok, Assistant Executive Engineer, PIU, Pathanamthitta is provisionally promoted to the post of Executive Engineer and is posted as such in PIU,

Thiruvananthapuram.

iii. Sri. P. J. Thankachan, Assistant Executive Engineer, Idukki Block, Idukki is provisionally promoted to the post of Executive Engineer and is posted as such in District Panchayath, Idukki.

iv. Sri. Srinivasan C., Assistant Executive Engineer, Peravur Block, Kannur is provisionally promoted to the post of Executive Engineer and is posted as such in PIU, Pathanamthitta.

The incumbents shall join forthwith in their respective posts and furnish the RTCs to Government without fail.

The interim order of the Hon'ble KAT, read as 1st paper above is complied with accordingly.
