An amount of Rs.9,50,57,660/- was withdrawn in 2019-20 from the PSTSB Account No.799012700000161 of Capital Region Development Project as per G.O. read as 1st paper above. The Special Officer, CRDP II, as per letters read as 2nd paper above has requested to refund the resumed amount for effecting payment towards the preparation of DPR for Outer Area Growth Corridor Project and other expenditure.
