### **ORDER**

The Government of India had sanctioned 33 road works under PMGSY I. The Kari-Mayicha Road under Package No.KR-05-59, Nileswar Block, Kasaragod District is one of the road included in the sanctioned list for an amount of Rs.98.83 lakh. The work was technically sanctioned for Rs.85,67,030/- by the CE, KSRRDA and the work was tendered via E-Tender. But a single tender was received at a quoted rate of 19.10% above the estimate. As per the clause 4(iv) of the G.O read as 1st paper above the maximum admissible tender excess shall be limited either to the quoted rate of the lowest bidder or local market rates or current DSR plus 10% tolerance limit whichever is less. After scrutiny, it was found that LMR is the lowest. The contractor expressed his willingness to do the work @15.89% above estimate rate which is as per LMR.

- 2. In the above circumstances, the Chief Engineer, KSRRDA, as per the letter read as 3rd paper above, has submitted the Revised Estimate to Government for approval of Administrative Sanction for an amount of Rs.1,08,21,844/- having an additional amount of Rs. 1,38,844/-.
- 3. Government have examined the matter in detail and are pleased to accord Revised Administrative Sanction to the work of Kari-Mayicha Road under PMGSY-I, Package No.KR-05-59, Nileswar Block, Kasaragod District for an amount of Rs.1,08,21,844/-(Rupees One Crore Eight Lakh Twenty One Thousand Eight Hundred and Forty Four only) subject to the condition that Revised Technical Sanction shall be issued by the Technical Sanction Authority for the agreed PAC before award of work. The additional amount required for the work Rs.1,38,844/- may be allowed from the head of account
