ORDER

The Hon'ble Kerala Administrative Tribunal, as per its order read as 1st paper above, has disposed of OA 733/2015 permitting the applicant to submit a copy of the Annexure MA2 representation, along with a copy of the order of the Hon. KAT to the 1st respondent, the Secretary, LSGD, within one month from the date of order and directed that, if that is done within one month, the 1st respondent should consider and pass orders on the MA2 representation after affording an opportunity of being heard to the applicant, within 3 months from the date of receipt of the representation.

2. However, the applicant has not yet submitted MA2 representation to Govt pursuant to the KAT direction. The Chief Engineer, LSGD, vide letter read as 2nd paper above has also reported that the applicant has not submitted the MA2 representation in that office also. As such, the applicant was asked to report as to whether he had preferred MA2 representation before Govt, and if so to furnish the copy of the same, vide Government letter read as 3rd paper above, but the applicant has not responded to this also, till date.

3. In the above circumstances, Government is not in a position to comply with the order of the Hon'ble KAT read as 1st paper above, due to the non-submission of MA2 representation by the applicant, pursuant to directions of the Hon. KAT therein.
