ORDER

As per the letter read as 2^{nd} , 3^{rd} and 4^{th} papers above, Government of India have sanctioned a total amount of 19,52,79,000- as part payment of the 1st installment of the Central Share for implementation of the NRLM for the year 2020-21. Of which General component is 6,54,59,000-, SCP component is 7,68,42,000- and TSP component is 5,29,78,000-. As per the letter read as 5^{th} above, the Executive Director, Kudumbashree has requested to release the aforesaid Central Share along with the corresponding State Share for the above purpose.

- 2. Government have examined the matter in detail. Since sufficient fund is not available in the State Share of TSP component under the H/A '2501-06-796-99', the release of TSP component will be considered after getting Additional Authorization.
- 3. In the above circumstances, Government are pleased to accord sanction to the release of a total amount of ₹23,71,68,333/- (Twenty Three Crore Seventy One Lakh Sixty Eight Thousand Three Hundred and Tnirty Three only) being Central Share and matching State Share to Kudumbashree for the implementation of the NRLM in Kerala for the FY 2020-21 as detailed below:-
