ORDER

Shri.P.Radhakrishnan was promoted as Corporation Secretary /Additional Corporation Secretary and he joined in the post of Corporation Secretary/Additional Corporation Secretary on 18.05.2017. The probation period in the post of Corporation Secretary/Additional Corporation Secretary is six months duty within a continuous service period of one year. As such, the probation period of Shri.P.Radhakrishnan was w.e.f. 18.05.2017 to 17.11.2017. But in compliance with the order dated 01.06.2018 of the Hon'ble Kerala Administrative Tribunal in O.A.(Ekm) No.1075/18, as per the Government Order read as 1st paper above, the probation of Shri.P.Radhakrishnan in the cadre of Corporation Secretary/Additional Corporation Secretary was declared w.e.f. 17.11.2018 by extending the period of probation under Rule 21 of General Rules of KS&SSRs, since disciplinary action was pending against him in three cases.

2. Disciplinary action initiated against Shri.P.Radhakrishnan was finalised by exonerating him from all the charges imposed against him.
3. Shri.P.Radhakrishnan has submitted the representation read as
