ORDER

The Budget Provision to the Local Governments has been modified vide Government order read as 5th paper above in tune with the recommendations of the XV Finance Commission. As per the recommendation, an amount of Rs.339 crore has been allocated to Million Plus cities (Urban Agglomerations) as Tied Grant for the FY 2020-21 (6 Municipal Corporations and Malappuram Municipality).

2) An amount of Rs.78,27,91,000/- ,**vide** Government order read as 4th paper above was already authorized to Million Plus cities for clearing the bills in the Treasury queue . This amount was allocated as Basic Grant under 15th FC to Million Plus UAs in the modified Budget Provision since there was no award under Basic Grant has been recommended by XV Finance Commission to these UAs.

3) Since then many UAs have requested to authorize amount under Basic Grant to clear the bills which are still in the Treasury. Government have examined the matter in detail and are pleased to issue the following orders as per additional authorization issued vide Government order read as 6th paper above:

- a) An amount of Rs.117,41,86,500/- (Rupees One hundred and Seventeen crore Forty One lakh Eighty Six Thousand Five hundred only) is authorized as FFC Basic Grant to 6 Municipal Corporations and Malappuram Municipality for clearing the bills in the Treasury queue as detailed below:


